- Meeting opened at 7:11 pm
- Minutes from last meeting motion made to accept and seconded and accepted unanimously

They found plants didn't look as healthy and the really dense bladderwort there seems to have mostly lost its flowers and died off.. - Lodge Water line repair: Tabled until someone can figure out an affordable solution.
- Lights around lodge, tabled for now.
- Lodge window needs repair. Bob B. will follow up.

- Lee suggested we lock the boats at the lodge. Lock them at the beach with a note that says if we don't hear from them, we will consider the boat abandoned and removed by fall. We will ask people to put a number on their boat and we will keep a data base.
